Every entry at a recognized competition, shall constitute an agreement and affirmation that all participants (which include without limitation, the owner, lessee, trainer, manager, agent, coach, driver, rider, handler and the horse), for themselves, their principals, representatives, employees and agents; (1) shall be subject to the constitution and rules of the association(s) and the local rules of the competition; (2) represent that every horse, rider, driver and handler is eligible as entered; (3) agree to bound by the constitution and rules of the competition, and will accept as final the decision of the hearing committee on any question arising under said rules, and agree to hold the competition, the VHSA, VSA, their officials, directors and employees harmless for any action taken; (4) agree that as a condition of entry, they authorize the VHSA, VSA, and/or the competition management to market, transfer, assign or otherwise make use of any photographs, likeness, films, broadcasts, cablecasts, audiotapes taken of the horse(s) and participants while on the grounds, incidents to, or in transit between the stabling facility and the event site, in any way they see fit for the promotion, coverage or benefit of the event, sport, or the VHSA, VSA, without compensation fully aware that horse sports and the competition involve inherent dangerous risk of serious injury or death, and by participating they expressly assume any and all risk of injury or loss, and they agree to indemnify and hold the VHSA, VSA, the competition and their officials, directors, employees and agents harmless from and against all claims including for any injury or loss suffered during or in connection with competition, whether or not such claim, injury or loss resulted, directly or indirectly, from the negligent acts or omissions of said officials, directors, employees or agents of the VHSA, VSA, or competition. The construction and application of VHSA and VSA rules are governed by the State of Vermont, and any action instituted against the VHSA and VSA must be filed in Vermont State. **Under Vermont Law, an equine activity sponsor is not liable for an injury to, or the death of, a participant in equine activities resulting from the inherent risks of equine activities that are obvious and necessary, pursuant to 12 V.S.A. 1039.**
